# Silver Oaks Subdivision Phase 1 Board Meeting

#### December 13, 2005. Main items:

- 1. Ashley Barrineau of the Okaloosa County Sheriff's Department gave those attending a very well done presentation on Neighborhood Watch (NW) programs. She explained "teen court" and it's success rate. And, she provided excellent tips for dealing with crime and related matters in our neighborhood. Kim Bowman and Vic Fleischer of Silver Oaks Phase I volunteered to be our focal points for the NW program. More to come on this program. Thanks to Kim and Vic for stepping up to this.
- 2. Collection efforts and solutions for 2005 lot owner assessments were approved. Only three lots remain. No liens have been necessary so far. Cooperation has been very good.
- 3. Our 2006 accountant contract with Michael S. McDuffie, CPA PA, Crestview, FL was approved.
- 4. 2006 budget, association fee (\$185.00 per lot), due date (30 January 2006) were approved. Invoices for lot owner assessment fees should be in the mail by December 15, 2005.
- 5. Improperly stored trailers were discussed. Two homeowners have responded favorably to suggestions that they properly store their trailers. Board is looking into whether fines or other corrective measures can be taken against those that fail to comply with this requirement.
- 6. Mail Box Stations. Some residents have problems concerning their damaged mailbox stations. The Covenants, Conditions, and Restrictions of Silver Oaks Subdivision, Phase I, Article V, Section 3 says, "Mailbox stations shall be identical and will be supplied by the developer at its cost not to exceed \$150.00." The developer no longer supplies these mailbox stations. And, there is no known local supplier that has these or all parts thereof on their shelf. Your Board of Directors has come up with a solution to this problem that we think will be acceptable for the time being. See related article below by Barbara Cole.
- 7. Yard of the Month. Congratulations to the Lee family at 5847 Saratoga Drive.
- 8. The vote on granting Silver Oaks, Phase I, Home Owners' Association Board of Directors Variance Authority for the requirements within Declaration of Covenants, Conditions, and Restrictions of Silver Oaks Subdivision, Phase I, dated September 15, 1998 is ongoing. NOTE: See article on page 2 for update concerning votes received after the meeting.
- 9. Edwin Santos discussed Silver Oaks Phase I resident petitions underway for:
- a. Speed bumps on Hunting Meadows and Saratoga between Hunting Meadows and Sorrel Ridge Road.
  - b. Sidewalk/bike path from entrance of Silver Oaks Phase I to Davidson Middle School.
- 10. Filling of the Board Secretary position was tabled until next meeting. We do not have a volunteer for this position.

- 11. Barbara Cole presented a quote to install video surveillance cameras at two locations within Silver Oaks Phase I due to recent crime problems in the area. Action on this quote/project was tabled for six months pending results of Neighborhood Watch program. In addition, two homeowners present voiced strong opposition to any video surveillance in our area.
- 12. Barbara Cole was tasked to prepare a paper on installation/approval process for satellite dishes within our area.
- 13. The great efforts our Common Area Decoration committee were recognized. Heather Coleman and Erin Lamkin did a superb job on this. Please check out their efforts especially at night at the front of our area.

Our next Silver Oaks Phase I Home Owners Association Meeting will be January 10, 2006 at Davidson Middle School. We look forward to seeing your smiling face at the meeting.

# Vehicles, Trailers, and Boat Storage

Declaration of Covenants, Conditions and Restrictions of Silver Oaks subdivision, Phase I, Article IX, Section 5 continues to say, "Vehicles, Trailers, and Boat Storage. Inoperative vehicles, travel trailers, recreational vehicles, commercial vehicles, buses and trucks with more than six wheels, boats and trailers, if stored on a Lot shall be kept in a concealed manner: closed garage, storage space, or within a fence, all so as not to be observable from other Lots or Common Areas. Garage and storage spaces must be approved by the Architectural Committee."

If you have a utility or any type trailer sitting in your driveway unconcealed for more than 4 days, we will appreciate it if you take it upon yourself to get it into proper storage. Same goes for inoperative vehicles or boats.
