Message from the Board...

Dear Homeowners,

The following is a letter received by the board. The violation addresses and author's name have been deleted.

Steve:

Listed below are violations of the C&R. Please put these items on the agenda for discussion at the next board meeting.

- 1. Political sign.
- 2. Mailbox damaged since early May, homeowner has replaced mailbox this week with mailbox station that is not in compliance with the C&R.
- 3. Pop-up vehicle cover.
- 4. Inoperable vehicle and 4-5 white buckets at end of drive-way.
- 5. Trash can still stored in view of street and neighbors. Trailer in driveway.
- 6. Ladder and other items stored at end of driveway.
- 7. Inoperable vehicle containing junk, red trailer exposed to neighbor.
- 8. Political sign.
- 9. Two trash cans stored along side residence.
- 10. Religious sign.
- 11. Trailer in driveway.
- 12. Political sign.
- 13. Political sign.

These complaints have been brought to our attention on a regular basis. This is to inform you of the process taken to try to rectify these complaints. Some of these complaints have been ongoing for 2 years or more with no resolution in sight.

Steps Present Board Takes


- 1. The first step is to go to the homeowner in person and make sure they are aware they are in violation of the Covenants and Restrictions.
- 2. The second step is to go in person again followed by a letter sent to the homeowner.
- 3. The third step is to send a registered letter. We still try to talk to the homeowner in person. This is an ongoing process of continuously talking to the homeowner and trying to make them aware of the violation.
- 4. Our final step is to go to an attorney. This has not been done on any of the issues below mainly because the previous board voted against it, and to be quite frank, we have to agree. It would be silly for us to bring a law suit against someone over a garbage can.

Everyone must remember if we bring your neighbor to suit we are representing you. So the board is asking if you are the homeowner's not in compliance with the Covenants and Restrictions, please do the right thing and fix the problem. We have some homeowners who comply and have to pay to store their boat, RV, or trailer. So, we ask this of all of our homeowners because this is the fair thing to do.

Thank you in advance for correcting the violations listed below and we hope to see some improvements soon.

I am very pleased to announce that the SOHOA has ended the year well within budget. We are approximately \$6,000.00 ahead of where we were last year. There were two major categories that contributed to this positive outcome. First, we collected approximately \$1,000.00 more from undeveloped lot owners to maintain their lots. And Secondly, approved reimbursements for 2010 was approximately \$2,200.00 less than 2009. We have changed some of the accounting procedures and this has helped greatly to cut back on expenses



United Nations Day October 24th



In 1947, the United Nations General Assembly declared 24 October, the anniversary of the Charter of the United Nations, as which "shall be devoted to making known to the peoples of the world the aims and achievements of the United nations and to gaining their support for" its work.

In 1971 the United Nations General Assembly adopted a further resolution (United Nations Resolution 2782) declaring that United Nations Day shall be an international holiday and recommended that it should be observed as a public holiday by all United Nations member states.

United Nations Day is devoted to making known to peoples of the world the aims and achievements of the United Nations Organization. United Nations Day is part of United Nations Week, which runs from 20 to 26 October.

Commemoration

United Nations Day has traditionally been marked throughout the world with meetings, discussions and exhibits about the achievements and goals of the organization. In 1971, the General Assembly recommended that member states observe it as a public holiday.

Several international schools throughout the world also celebrate the diversity of their student body on United Nations Day (although the event is not necessarily celebrated on 24 October). Celebrations often include a show of cultural performances in the evening and a food fair, where food is available from all over the world.

In the United States, the President has issued a proclamation each year for United Nations Day since 1946. The most recent such proclamation was issued by Barack Obama.

In Kosovo, United Nations Day is an official non-working day as the province is administered by the Interim Administration Mission.
